CONSERVATION LOTS & ASSET PROTECTION ZONE – STAGE 5





CONSERVATION AREAS ON PRIVATE LAND

Conservation areas to be adopted within these areas will ensure protection of existing ecological values and features.



Conservation Blocks protect areas that are considered important for maintaining ecosystem function. Metres and bounds of conservation areas are to be determined generally in accordance with this plan and recorded as conservation areas on the relevant survey plan.

Vegetation Protection Conservation areas shall be entered into with the State of Queensland on the terms nominated by the Department of Natural Resources and Mines as appropriate in the circumstances.



Asset Protection Zones (20m) (radiation zone for fire protection) are to be established and managed in accordance with the Bushfire Risk Assessment and Mitigation Plan prepared by Bushland Protections Systems Pty Ltd.



Easement Zones (EMT) are allocated areas required by Council to support the performance of a particular function relative to the site's usage. EMT zones have been recorded on the relevant survey plan and meet Standard requirements.
